Amendment No. 1 to the Measure of the Dean of the Faculty of Economics No. 219/2022 on the obligations of doctoral students in the study program Economics and Management at the Faculty of Economics, University of South Bohemia in České Budějovice

September 1, 2025

Article 1 Introductory Provisions

- 1. This measure (hereinafter referred to as 'the Amedment') amends the Dean's Measure No. 219/2022 on the obligations of doctoral students in the Economics and Management study program at the Faculty of Economics, University of South Bohemia in České Budějovice (hereinafter referred to as the 'DSP measure'), namely:
 - a) Article 2 Standard course of study and deadlines for fulfilling study obligations adjustment of Table 1 Standard course of study
 - b) Article 2 Standard course of study deletion of paragraph 4
 - c) Article 3 Additional obligations amendment of obligations.
