# Scientific Focus of the Department

The **Department of Regional Management and Law** is an important part of the Faculty of Economics of the South Bohemian University. It represents an **interdisciplinary approach to teaching and research**, shaped by the **ideas of regional and sustainable development, environmental and ecological economics and a pluralistic concept of economics** (i.e. plurality in theory and methodology and interdisciplinarity). The Department **combines a theoretical interdisciplinary approach with a practical focus on regions and their needs**, which takes the form of **cooperation with mayors, the creation of municipal development plans, the preparation of projects and consultations with representatives** of national and regional associations of Local Action Groups.

The **Law Section** ensures the teaching of subjects and the development of topics in the **field of legal disciplines, with a focus on both economic and technological fields. Civil and commercial law** (with an emphasis on corporate law and insolvency law closest to economics), **administrative, trade, financial and labour law** are further developed. Particular attention is paid to the development of the teaching of **European law**.

The **diversity of approaches is also due to the personnel composition of the department**, whose members have, in addition to economics, law and regional studies, a background in sociology, geography, political science, cultural studies and applied ecology.



# Scientific Focus of the Department Summary

## **Regional management research:**

1. Balanced and sustainable development in the regions in terms of the SDGs,
2. Economic alternatives - green economy, bioeconomy and circular economy,
3. Socio-economic solutions to the energy and climate crisis.

Topics currently addressed include circular bioeconomy, socio-economic aspects of environmental degradation and alternative food production, brownfields issues, the role of local action groups in the Czech Republic and the EU, comparison of strategic documents at the national regional level, measures to support ecosystem services in the landscape and support for the development of smart regions and cities.
